








the ILL shall conduct preliminary enquiry, so as to ascertain the truth of the complaint & shall co-ordinate the deliberation on the complaint received.



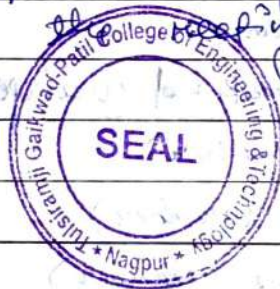
Agenda 3: Need to increase awareness of committee

- SGRC received a complaint regarding problem in attendance marking of few students who went for outside participation.



Resolution 4: All members of the ICE approved the suggestion and the responsibility has been given to WGRCC (Women's Grievance Redressal Cell) to plan a




