- 1. SPAST and its entities shall coordinate and arrange supervisors through LUCM.
- 2. SPAST and its entities shall arrange the six online review meetings at an interval of 2 months.
- 3. SPAST and its entities shall organize conferences and the researchers of the partner university have to fulfil the requirements of the programme.
- 4. Through the conference thorough guidance shall be provided to researchers of the partner university/institute/college (Partner organization) on research strategies, publication strategies and publishing options.
- 5. Partner organization will encourage its researchers to enrol for the programme as many as possible. This is necessary as it will enhance the research engagement and ranking of the partner university through increased SCI/SSCI/EI SCOPUS journal publications.
- 6. Partner organization shall send atleast 4 reminders before each enrolment cycle to its staff and researchers.
- 7. Both parties will publicize the partnership through websites and inclusion of logos on each other's websites.
